Parish Council Notes

The Parish Council met virtually during April and May. The legislation which allowed virtual meetings has now expired as it was only temporarily in place during the recent lockdowns. The Council is now back to 'in person' meetings in the Village Hall. The village hall is registered as a covid-secure venue and social distancing and other safety measures are in place during meetings to ensure the safety of those attending. Public and press are most welcome to attend and meetings are held in the main Hall so please access the meetings through the main door to the Village Hall.

At the last two meetings, various planning applications were discussed, and these are shown in the minutes of each meeting which are published on the Parish Council's website.

There are still two vacancies on the Parish Council if any residents are interested. Please contact a Council member or the Clerk for further information.

May saw the Annual Parish Meeitng for the Village held just prior to the monthly meeting of the Council. This is a meeting for residents to raise issues etc. At that meeting the Chairman also officially released the Annual Report of the Parish Council for the year 20/21 and this is published within the Newsletter.

The Chairman for 21/22 will be Cllr. Paul Gilbert once more and the Vice-Chairman will be Cllr. Trevor Crofts. All other members remain the same as for the previous year.

The Council will be looking to refurbish the play area with professional repainting, changes to the flooring and some new equipment.

Immingham Habrough & Stallingborough Report for May

Crime

There were 63 crimes recorded for April in the Immingham, Habrough and Stallingborough area of the NPT.

These included:

Domestic Burglary:

During the early afternoon of 19th April two males entered the rear garden of a property on Pilgrim Avenue by climbing over an adjoining fence. They forced the bottom of an up & over door causing an alarm to activate. The males made off empty handed. Around lunch time on 28th April an attempt was made to force a garage door at a property on Berwick Court. No entry was gained. About 6pm the same day a door handle was tried at home on Sackville Road. The door was secure so no entry gained.

Commercial Burglary: 1 On 7th April the Immingham Golf Club was broken into through a balcony window. It is unknown if anything was stolen.

Damage 4:

Oasis Academy windows smashed. Hadleigh Road house windows smashed. Sackville Road damage to a house window . Waterworks Street graffiti painted on a car. Oakham Walk damage to a garden fence.

Other crime include:

During the early hours of 16th April a trailer with a container carrying goods to a value of about £40,000 was stolen from a secure compound at a transport company on Stallingborough Industrial Estate.

Fifteen assaults. Nine public order offences. Four shop thefts. One juvenile male has been dealt with by way of Community Resolution for one of these offences at Aldi. Three offences of malicious communications.

GENERAL INFORMATION FOR RESIDENTS:

Ward Cllrs. were explaining to the Council members why registration numbers were taken at the public tips/recycling centres—not necessarily for the reasons members had thought.

Registrations are taken and monitored to help stop frequent users who do not live in NE Lincs accessing the facilities. Residents pay for the tip through their Council tax and the Council don't want those from outside of the area, who are not financial contributing to the tip, to use it. Frequent visitor number plates are checked against the number plate register and if from outside of the area, the Council will prevent them from using the facilities.

The Council members thought residents might like to know the main reason as to why number plates are checked at the tips.

THE BARTON & CLEETHORPES COMMUNITY RAIL PARTNERSHIP June 2021

The Barton & Cleethorpes Community Rail Partnership was formed in 2007 following a government initiative to encourage community participation in the running of certain designated rail lines and the B & C was one of them.

The forum consists of representatives from parish councils (myself included), local authority officers and councillors along with representatives from the Network Rail, the train operators, and other interested parties.

As part of the community activities, included is keeping track of any job opportunities that arise with the train operating companies and with grateful thanks to my colleague Councillor Scott, they will if possible, be posted on the Stallingborough Facebook page.

News

As you may be aware the Barton Cleethorpes service is now operated by East Midlands Trains, all the trains having at least 2 coaches and a Sunday Service is provided. The timetable operative from 16th May till 11th December, is summarised at the end of the article. A downloadable timetable is available at www.bccrp.co.uk.

Also there is a major change on the EMR service from Habrough towards Lincoln.

These trains will now continue to Nottingham and Leicester but they will no longer stop at Newark Northgate on the East Coast Mainline. I hope to say more about this in the next Newsletter.

Lastly for anyone planning a journey with LNER trains on the East Coast Mainline a reservation is now mandatory on these trains.

The Parish Clerk during the year was Kathy Peers, a CiLCA qualified Clerk.

Cllrs. Stewart and Karen Swinburn were present at the majority of the meetings in their capacity as Ward Cllrs., NELC for the Stallingborough and Immingham Ward.

<u>General</u>

Members of the public occasionally attend meetings and raise issues with the Council members and this still took place during virtual meetings. A written report from the local policing team is received each month and circulated to all members.

The Council started the year with 7 members and two vacancies and closed the year with 7 members and two vacancies.

Planning Matters

The Parish Council is a statutory consultee of the local Planning Authority, which is North East Lincolnshire Council. The Parish Council

is consulted on every planning application within the Parish and also those which are on its boundary or close to its boundary within a neighbouring Parish.

During the year 20/21, the Parish Council was consulted on 24 planning applications and the comments agreed by the Parish Council are all published on the website as part of the monthly minutes.

Major planning applications for the year have been based on the industrial estates.

The Parish Council also continued to liaise with local residents, neighbouring Parish Councils, North East Lincolnshire Council and

Development teams.

PRODUCE SHOW

Stallingborough Village Newsletter and Website

The Parish Council organises and publishes the Stallingborough Village News bi-monthly throughout the year. The Newsletter is delivered to every household in the village and is professionally printed, with some financial support coming from sale of advertising space. This has continued all through the pandemic.

The Parish Council is grateful to all those who have advertised their services or businesses and groups and events through the Newsletter and especially value the contributions made from village groups on reports of their activities etc.

Costs for printing and distribution totalled $\pounds1,156.00$ for the year.

The Newsletter is 'desk-top published' by the Clerk to keep printing costs to a minimum and then copies run off by a printing company.

The Parish Council now has its own dedicated website which can be updated by the Council's own staff and also towards the end of the year started a Facebook page. The website is hosted by Mariner Computers at a cost of $\pounds120.00$ per year.

Stallingborough Village Hall

The Parish Council owns and runs the Village Hall on behalf of the residents of Stallingborough. During the pandemic the Hall was closed following Government regulations but did manage to open for a couple of months when restrictions were eased between lock-downs. Revenue has been seriously impacted for the year due to the lockdowns and some groups have ceased during the pandemic and will not return.

Revenue for the year totalled $\pounds1,693.00$ for the two to three months during the year that the Hall managed to open. Costs for the running of the Hall however still had to be met, and the running costs for insurance, energy and water supply, grounds maintenance, waste disposal and any necessary checks totalled $\pounds5,207.00$.

We are certainly more hopeful now that the Produce Show can go ahead this year on the 4th September

At the moment we are not quite sure if it will be the usual format, and we will try and make it

enjoyable, but within the guidelines.

We hope to have a meeting after the 17th May and get the schedule organised.

We will keep you informed via the village Facebook, and I will put more details in the



The Parish Council employs 3 staff for the Village Hall – two Caretaker/Cleaners who job-share the role and a relief/weekend Caretaker. Village Hall staff were furloughed as and when appropriate during the year with claims made to HMRC, and staff salaries were kept at the usual level throughout the year.

The Bar has not been used at all throughout the year.

When the Hall was allowed to open, it was registered as a Covidsecure venue, with QR check-in codes, sanitisers throughout the building and all necessary health and safety assessments carried out in line with Government guidelines for public buildings.

Land ownership/management

The Parish Council owns land on which the children's playaround and football pitches are situated, as well as a youth/teen shelter.

There is also a pavilion on the site for use as storage and changing rooms.

The pitches are available to be hired out by local football and cricket teams and again the pandemic affected the use of the facilities with no sport allowed for part of the year and also playgrounds closed for one of the lockdowns.

The Parish Council maintains the whole site, cutting the grass, ensuring the play equipment is properly maintained and having the bins emptied etc. and this is carried out through two grounds maintenance contractors with the works put out for quotation each year – one contractor cuts the large area of grass on the playing fields and the other maintains the playaround area, litter picks and also looks after the Village Hall grounds each month.

During the year, the Council still had its annual ROSPA inspection of the play area carried out and also carried out any essential repairs to the site highlighted in the report.

The Parish Council also owns a small allotment site off Leggott Way, which is always fully subscribed and also a small area of land adjacent to the site which it maintains as part of is annual grounds maintenance contract.

During the year the Parish Council continued to assist the Church with its churchyard maintenance – employing a contractor to carry out the work and has also included this ongoing maintenance within its budget for the following financial year.

The Parish Council also has a long-standing arrangement with the Target/Gun Club which uses the rifle range attached to the side of the Village Hall. A nominal peppercorn rent is paid each year and a donation also made by the Club to the Parish Council for the Council to donate to a charity of its choice.

The year saw some major tree works taking place alongside the railway by Network Rail and some of the trees on the Parish Council site were included in works undertaken by Network Rail. The Parish Council had several meetings and agreed a scheme of works for the trees owned by the Parish Council so as not to cause any problems with the railway.

Network Rail very kindly organised 100 trees to be donated which the Parish Council then arranged to have planted on the playing fields, away from the railway line. Network Rail also, as part of its commitment to improvements within the Village, organised the removal of a large tree at the Primary School free of charge.

The accounts are audited each year through a specified process set down in legislation nationally, with an internal audit being carried out and then an external audit carried out by PKF Littlejohn, based in London, who are appointed through a national body and not by the Parish Council. The Parish Council complies with the necessary period of public inspection of the accounts each year and puts financial information on its website and in its bi-monthly newsletter where appropriate.

The Council met during January 2021 to set is budget for the coming year and to agree its precept requirement for the coming financial year. The agreed budget was, as always, printed in the next available edition of the Newsletter.

General Matters

Once again the Parish Council organised a Christmas Tree for the village and this was very kindly donated as in previous years by the Hoyes family. The Parish Council owns its own set of lights for the tree and each year these are very kindly put onto the tree by NE Lincolnshire Council and McCanns.

A Remembrance Day service was once again held, within necessary restrictions in force, at the Community Garden.

The Council supported a residents group which has been formed to carry out planting and environmental improvements in the village and the group has liaised with NELC regarding planting on verges and roundabouts within the village to improve the local surroundings.

This has also been supported through Ward Councillor funding.

The Parish Council also donated funding to the local lifestyle group to improve the decorative feature at the entrance to the Village.

Right at the end of the year, the Ward Cllrs. advised that following lobbying from the Parish Council and residents, that the lay by on Riby Road would be permanently stopped up. The Parish Council had been highlighting anti-social behaviour problems in this location for many months and was pleased to see this matter come to a satisfactory outcome.
